Introduction

The Health Resources & Services Administration (HRSA) offers funding through four loan programs to undergraduate and graduate schools. Schools then offer these need-based loans to students pursuing a health professions degree. Each loan is long-term and low interest.

Students then deliver health care to people who lack access to primary health care services upon completing their medical education.
